### Dear friends,

As uAspire enters our 40th year of supporting students' post-secondary aspirations, we recognize we could not have done it without your support. This past year alone, we've had to navigate a changing financial aid landscape that includes a redesigned Free Application for Federal Student Aid (FAFSA), ambiguity around federal loan repayment, and the ongoing debate about the value of a college degree. Despite the challenges, uAspire has continued to innovate to ensure students and families have the support they need to make informed decisions for their educational future. By continuing to adapt, we positively impacted over 2 million students in 2023–24!

The U.S. higher education system is now undergoing a watershed moment as it strives to meet the changing needs of students, families, employers and communities amid evolving federal priorities and a rapidly changing social and economic landscape. As these dynamics shift, the need for affordable degree options continues to be paramount. Post-secondary education – whether a bachelor's, associate's, certificate or other short-term program – remains the most reliable pathway to well-paying jobs and economic mobility, and it must be accessible to all students. Our progress sustains us: uAspire students who fully engage in our programming are 3X more likely to graduate with a degree than their peers. It amplifies our focus on creating a more accessible and equitable postsecondary system, and pushes us to further invest and innovate on behalf of underrepresented students.

While we will never know with certainty what the future holds, what we do know is that uAspire will always remain steadfast in our commitment to supporting students and their families, building strong partnerships, and advocating for policies that create a more equitable and affordable postsecondary education for all students. Your continued support and collaboration are crucial on this journey, and we are deeply grateful for it.

The Crankstart Foundation approached uAspire for support in designing a scholarship for San Francisco students. Through an iterative process, our team reviewed the latest research and data, leveraged internal expertise, and interviewed students, practitioners, and other stakeholders to understand the community's needs and identify innovative scholarship solutions.

The final design included a transparent application process, flexibility of funds beyond tuition, and continued support and advising. The scholarship launched in four San Francisco Unified School District high schools in fall 2024 – proving that innovation can open doors.





## Speaking out to amplify student voices.

Fellows learn how to influence policy by researching policy solutions, writing op-eds, and speaking to policymakers – working together to advance change for themselves and their peers

This year, uAspire rallied all its forces to raise awareness and galvanize support for Universal FAFSA across NY state. FAFSA, the Free Application for Federal Student Aid, helps students apply for federal aid, from grants and scholarships to work-study programs and loans.

It was an all-hands-on-deck approach; our policy team developed a media feature spotlighting our staff and a Policy Fellow, hosted a legislative briefing, presented at the Black & Latino Caucus Conference, built a coalition, and launched a dedicated social media campaign.

In proof that passionate advocacy can move mountains, our efforts helped secure six new bipartisan legislative cosponsors – culminating in Universal FAFSA being passed in New York's FY2025 state budget.

My grandparents were my legal guardians, and I had no idea how to prove my independent status on all the official forms. In my junior year, a uAspire advisor visited my school and explained the basics of financial aid. The presentation was a turning point – I realized I could get help sorting out the details that felt so overwhelming. My advisor guided me through the process. She showed me how to fill out the FAFSA and CSS Profile, reminded me about deadlines, and encouraged me to consider private colleges offering more aid. Each time I checked something off my to-do list, I felt less stressed and more confident about going to college.

When Brandeis offered me a full scholarship, that sealed the deal - it showed me that all my hard work was worth it. Now that I'm on campus, I continue to feel supported. My new uAspire advisor stays in touch through texts and Zoom calls, helping me keep track of paperwork, answering housing questions, and generally checking in on how I'm doing. Looking back, I'm so glad I reached out for help when I did. It's amazing how having someone in your corner can make all the difference."

I wasn't always sure how to handle the financial side of college. One day, I got a text from uAspire, and my first thought was, 'who are these people, and how did they get my number?' But connecting with my first advisor, Jameiley, completely changed the process. She was patient and supportive every step of the way.

I've learned that **success is about using every resource available.** Looking back, I'm grateful for the challenges because they pushed me to grow. And I'm incredibly thankful for the support from uAspire – it made all the difference to have someone in my corner, encouraging me through both the personal and financial hurdles of college."



## Meeting the challenge of a changed FAFSA

The release of the 24-25 simplified FAFSA form created one of the most challenging financial aid environments in recent history for students, families, school counselors, and the rest of the financial aid community. Released two months late and rife with technical issues, it made applying for financial aid more burdensome for many and nearly impossible for some.

These challenges upended the traditional financial aid timeline, delaying financial aid offers and impacting college decisions, so uAspire stepped up and amplified its support to our students and the college community. It was effectively a proving ground for our students' resilience and determination.





### **Updating the field**

A research study about the experiences of students, families and educators with the 24–25 FAFSA, the publication was a precursor to our series of recommendations – proving our determination to improve future versions of the application.

Using AI to simplify our work behind the scenes will help us amplify our focus on more meaningful connections between our human advisors and the students, families and communities they serve.

#### **Creating an advising fellowship**

Advising students is where uAspire started – now it's time to rethink how we develop and support our frontline staff. We plan to launch a fellowship program that will invest in advisors' professional development while continuing to provide best-in-class support for students.

#### Leading with research

For all our new efforts, however, one fundamental of our work will never change: leading with research. As we make more decisions as to what's next at uAspire, our research – with students, families, educators, policymakers, and the industry – will help drive our thinking and allow us to continue to be a leading voice in the field.
